

Privacy Policy

General Information

1. This policy applies to the Website, which operates under the url: www.skinsproject.gg. Operator of the service and personal data Administrator is: DREALITY LTD Anastasiou Sioukri, 1 Pamelva Court, Flat/Office 33035, Limassol, Cyprus HE 433022, Email - admin@skinsproject.gg. The Operator is the Administrator of your personal data with regard to the data provided voluntarily on the Website. The protection of personal data takes place in accordance with the applicable laws, and their storage takes place on secure servers.

Data Protection

2. Selected data protection methods applied by the Operator The login and entry points for personal data are protected in the transmission layer (SSL certificate). In this way, personal data and login data entered on the website are encrypted on the user's computer and can only be read on the target server.

Cookies

3. www.skinsproject.gg uses cookies. Cookies are computer data, in particular text files that are stored in the final device of the Service User and are intended for use on the websites of the Service. Cookies usually contain the name of the website they come from, time of storage on the terminal equipment and a unique number.

The operator of the Website is the entity placing cookies on the Website User's terminal equipment and accessing them. Cookies are used for the following purposes: maintaining a session of the Service user (after logging in), so that the user does not have to re-enter login and password on each page of the Service. Session cookies are temporary files that are stored in the final device of the User until logging out, leaving the website or switching off software (web browser). Persistent cookies are stored in the final device of the User for the time specified in the parameters of cookies or until they are deleted by the User. Web browsing software (Internet browser) usually allows by default to store cookies on User's end device. Users of the Website can change their settings in this regard. Internet browser makes it possible to delete cookies. It is also possible to block cookies automatically. Detailed information on this subject can be found in help or documentation of a web browser. Restrictions on the use of cookies may affect some of the functionality available on the Website.

Cookies placed in the Service User's end device can also be used by entities cooperating with the Service Operator, in particular this concerns companies: Google (Google Inc. based in the USA), Facebook (Facebook Inc. based in the USA) If you do not want to receive cookies, you can change your browser settings. We stipulate that disabling cookies necessary for authentication, security and maintaining user preferences may hinder or, in extreme cases, make it impossible to use the websites.

Where do we transfer your data?
